Retail promotions attracted people downtown and made cash registers ring for businesses. These included: Downtown Loves Moms, Pre-Prom, Downtown Loves Dads, Movies Under the Stars, Downtown Rumble, Haunted Downtown, Small Business Saturday, and New Year Celebration on the Plaza.
