NJ Offers Free Support for Retailers Shifting to Online Sales N.J. Business Action Center and N.J.'s Small Business Development Centers offer guidance, tools to help small businesses set up successful e-commerce platforms, market online

The New Jersey Business Action Center (NJBAC), in partnership with New Jersey's Small Business Development Centers (NJSBDC), will offer free tools and resources to help retail businesses capitalize on the approaching holiday season amid COVID-19. The services are designed to help small businesses that typically rely on in-person transactions shift to e-commerce.

"From helping to set up an e-commerce website to talking through pricing strategies, we've helped numerous small businesses in the state set up successful e-commerce platforms," said Kelly Brozyna, CEO and state director of the NJSBDC. "We work closely with our clients to understand what they

need to build and sustain online sales, learning about their specific technology, logistics and supply chain capabilities."

Resources include personalized consulting, website setup, social media promotion, Google My Business support and SEO strategies. Businesses can also receive counsel on managing inventories, product descriptions and pricing strategies to maximize online sales and profits.

"Many small businesses feel overwhelmed by technology, but we are available to help them overcome that hurdle," continued Brozyna. "We've helped dozens of businesses in the state launch e-commerce platforms in the past year. We welcome the opportunity to offer our services to businesses that need to incorporate digital solutions into their framework."

Business owners can also join virtual e-commerce workshops, which range from understanding marketplace platforms, online payment setup, business development logistics and launching e-commerce businesses.

- "Social Media Marketing for the Holiday Season" will educate business owners on three key strategies to starting and growing an online business during the holiday season, including social media, business development and generating online traffic. The program is available on demand.
- "The Basics of Online Marketing" on Thursday, Dec. 10 at 10 a.m. ET will provide insight on the core elements of improving small and medium businesses' understanding of online marketing strategies amid COVID-19.

Main Street New Jersey COVID-19 Relief Program

The Metuchen Downtown Alliance (MDA) has received \$295,958 in Main Street New Jersey COVID-19 Relief Program funding from the New Jersey Department of Community Affairs. The \$1.6 million Main Street New Jersey COVID-19 Relief Program provides district management organizations that actively participate in the Main Street New Jersey

Program funding for eligible COVID-19 response, recovery, and revitalization efforts in small business districts. Funded by the federal Coronavirus Relief Fund, program funds can only be used for expenditures incurred between March 1, 2020 and December 30, 2020, such as personal protective equipment and sanitizers, COVID-19 protocol training for employees, permits and fees, and equipment required to reopen and conduct business safely, including outdoor furniture and heaters, plexiglass barriers, additional technological devices, and more. Only businesses in the Metuchen Downtown District are eligible to apply.

Businesses receiving Main Street New Jersey COVID-19 Relief Program funds from grantees must:

- Have been adversely affected by the COVID-19 pandemic, including temporary business closures, needing to furlough or lay off employees, or at least a 25 percent drop in sales;
- Have not received any COVID-19 relief funding from the New Jersey Economic Development Authority, New Jersey Redevelopment Authority, or any other state business recovery program used for the same purpose as MSNJ COVID-19 Relief Program funds;
- Have less than \$5 million in gross receipts as of the most recent tax reporting year;
- Have at least two and no more than 100 employees;
- Have had an operational, physical location within the district boundary as of March 17, 2020.

Economic Injury Disaster Loans

Finally, the Economic Injury Disaster Loans are accepting applications. Over 100 businesses downtown have applied for loans from a few thousand dollars up to the full available amount of \$150,000.
