#### **September 10, 2021**

#### 8:30 A.M. - Tent at Lotsa Balls on New St, and GotoMeeting

Eric Berger opened the meeting. Minutes were reviewed and a motion was made to approve the August meeting minutes. Motion passed.

There were no additions to the agenda.

#### **Chairman's Report**

Eric Berger reported:

- The New Street tents will need to be taken down to accommodate installation of new gas piping on New Street. At a meeting with New Street businesses, the Mayor announced that the New Street tents can go back up after the gas pipe installation and remain for the balance of the calendar year.
- On September 20 the NJTPA will host a public meeting to discuss different options for New Street including a possible closure between Main Street and Pearl Street.
- The Board determined not to take a position on whether or not New Street should be closed due to lack of consensus among the Full Members. Trustees are free to express their own opinions, but may not speak on behalf of MDA.

#### **Treasurer's Report**

Stuart Schooler reported:

- The proposed MDA 2021 budget was shared with the Board and discussed. The highlighted changes included: grant revenue \$25,000 vs \$50,000 in 2020, Storefront grant program increased to \$45,000 vs. \$25,000, Education and Tech \$10,000 vs, \$0 in 2020 and Contract Services up to \$23,000 from \$15,000.
- The other budget lines/categories amounts are very close to 2020. Board discussion was held regarding the Contract Services line item and the various services covered.
- The motion to approve the budget was unanimously approved.

Over the last few weeks, the Borough and the North Jersey Transportation Planning Authority (NJTPA) have sought feedback about potential infrastructure changes to the intersection of Main Street, New Street and Hillside Avenue that were presented to the community during a virtual public meeting on September 20th. Changes to this intersection are being considered as part of the \$9.3 million NJTPA Main Street Safety Improvement Grant awarded to the Borough in 2017 and is designed to improve pedestrian safety along Main Street from Brunswick Avenue to Talmadge Avenue.

Throughout this deliberative process, so many of you provided formal feedback to the Borough because of your dedication to Metuchen and commitment to its future. As your submissions came in, I carefully reviewed every one of them. Many of you expressed varying concerns with one or both alternatives presented by the NJTPA. I am grateful that so many of you provided thoughtful suggestions on ways to make the intersection safer. Most emphasized the importance of, as one resident described, "traffic calming measures along Main Street and in all of Metuchen for that matter." As another resident wrote, many of you are "all for additional safety, better pedestrian lighting, painted streets and other support."

After a thorough and thoughtful review of all public comments, discussions with Council Members, and input from emergency service professionals, we have determined that neither of the alternatives presented by the NJTPA is right for our community at this time. Rather, we have asked the NJTPA's professionals to implement a different solution for the intersection that does not close New Street or result in significant parking loss on Main Street but incorporates some of the most common safety suggestions made throughout this process.

While this portion of the grant process is now complete and many residents engaged productively by weighing potential safety improvements against issues like increased traffic and limited parking, sadly other discussions, especially on social media, devolved into cynical assumptions about the motives of our own neighbors. Constructive disagreement and respectful dissent result in more rigorous decision-making that often requires us, as leaders, to challenge the way we think about our Borough. However, when disagreement turns to acrimony and we resort to claims that every opposing position comes from a place of dishonesty, we chip away at the very fabric of our close knit community.

Metuchen is a special place and it is so much more than one street or one intersection. Metuchenites have a proud tradition of community engagement and supporting one another. Our future is decided in moments like these, and while we may not always agree about what the future looks like, we must remain committed to the ideals of the Borough we call home. This is not the first time there has been disagreement about a policy issue in Metuchen and it likely won't be the last.




