### **Secretary's Report**

Meeting minutes from November were circulated prior to the meeting. Motion to approve the November minutes was made by Mr. McColley, seconded by Mr. Cea. Motion approved.

Ms. Mackey provided an overview of year-end and upcoming initiatives:

- Storefront Grant Program: Three grants recently approved
  - Greenhouse, Fresh Twist, and Salad House
  - Most grant money has now been distributed
- Spark Downtown: Mr. Muldoon provided updates on upcoming vendors

### **Communications Team**

Mr. Cea provided an overview of year-end marketing efforts:

- Holiday Video Campaigns: A series of "owner reels," "What's in the Bag" features, and "Shop Small" videos showcasing local merchants.

- Gift Guide Posts
- Print Advertising: Ad running in 08840 Magazine

Mr. Cea also informed the Board on his desire to step down as Marketing committee lead but his commitment to help in the transition and continue producing reels. The Board thanks Mr. Cea for all of his efforts.
